As you may be aware, Los Angeles County is now allowing for elementary schools to re-open for on-campus instruction due to dropping COVID rates for the first time since the pandemic has started.

Therefore, we're preparing for the following:

- One-one-One academic assessments for all students as needed beginning Feb 22nd.
- On-site learning for small cohort of students in Grades 6-12 (less than 25% of school population) beginning March 1st.
- Continuous COVID-19 testing for students, faculty, staff (1x a week)
- Vaccinations for educators who works on campus


In response, we are preparing for phased re-entry for hybrid (2x a week) on-site learning for all our students at ACES/TAS in Grades Tk-6..

We appreciate you taking the time to complete our survey on how you and your child would like to proceed once schools are declared safe to re-open.

There were over 200 responses from all 3 schools.

- Approximately 40% of families indicated intend to return for inperson hybrid learning once it is declared safe to return.
- Approximately 30% of families indicated not to send their child back for in-person learning
- Approximately 30% of families were unsure

Over the past 10 months TAS has made significant physical improvements to keep students, teachers and staff safe. Some of the campus and facilities safety measures include:



8 Thermal Scanners to safely and quickly take temperatures upon entry to the school



Desks separated 6ft apart with Individual desk shields for all students



Handwashing stations positioned throughout various locations



HEPA Air scrubbers installed throughout our air/HVAC system to filter out 99.9% of undesired contaminants entering into classroom.

TAS has developed protocols to ensure that any cases of COVID-19 are triaged and handled per Los Angeles County Department of Public Health guidelines.

Despite the challenges, many of our school services have remained open and operational during this time. Our Food Service Team has served over 230,000 meals since March 2020. This is a vital operation that helps support our students and community members.
