

**AMENDMENT TO MASTER TUTORING SERVICES AGREEMENT
& EXHIBIT A STATEMENT OF WORK**

This **AMENDMENT TO MASTER TUTORING SERVICES AGREEMENT** and **EXHIBIT A STATEMENT OF WORK** (this "**Amendment**") is entered into by and between HeyTutor Inc., a California corporation (the "**Company**," "**Contractor**" or "**HeyTutor**") and The Accelerated Schools, a California school district (the "**District**") (collectively, "**Parties**") on this 28th day of September 2022. The Master Tutoring Services Agreement and Exhibit A Statement of Work (the "**Agreement**") were originally executed by the Parties on the 18th of August 2022.

The Agreement is amended as follows:


