- 2. Prepare and fill existing cracks in concrete.
- 3. Apply KeyResin 635 Primer.
- 4. Apply two coatings of KeyResin 400 and broadcast sand to refusal.
- 5. Apply one coat of KeyResin PA Sealer.
- 6. Standard work hours: Monday Friday, 6:00am 2:30pm. (After hours available upon request)

EXCLUSIONS:

- 1. Furniture and equipment moving.
- 2. Borders, inlays, logos, or custom designs.
- 3. Moisture testing and treatment.
- 4. Removal of materials containing asbestos or lead.
- 5. Final cleaning, wax or sealers, and protection of stored or installed products.
