PUBLIC COMMENTS on Non-Agenda Items:

1. Elizabeth Reyes: Concern 1: Students are not receiving the adequate nutrition they need; Parent is requesting healthier foods, fruits, vegetables, salads, and fewer frozen foods. Hot meals should be served. Concern 2: The parent also requests that the school treat students equally and exterminate rats.
2. Anariel Diaz: Give students better meals. Parent is requesting better food and for food services personnel to wear masks.
3. Ignacia Sanchez: Concern 1- Wondering about the updates on the metal detectors and what has occurred since the recent survey was administered. Parent requested the change to install metal detectors be made now. The parent stated not having metal detectors says that we are ok with students not having cell phones on campus but we are ok with having weapons. Concern 2: Parent stated that a zero cell phone policy will result in more absences.

BOARD PRESIDENT'S COMMENTS AND REPORTS

Our Board President has visited our campus several times in the last few weeks. We have great students. They are receiving something here that they are not receiving elsewhere. The campus is beautiful. We have our own Food Services Director. Shout out to the students and staff. Thank you to our Board members for being here who have been impacted by the fires. Requesting the Food Services Director provide an update at the next Board meeting.

- Chronic Absenteeism Updates: Provided the difference between ADA and Chronic Absenteeism and why this matters; Update on our progress in this area: Reviewed current rates at ACES and TAS; Indicated that there is no CA Dashboard Chronic Absenteeism indicator for WAHS.
- Academic Data: Provided a review of the BOY to MOY Achievement in Math and Reading (ACES); BOY to MOY Achievement in Math and Reading (TAS ES); BOY Achievement in Math and Reading (TAS MS and WAHS); It was noted that a lot of work in Math is needed.
- BEST Process: Budget, Enrollment, Strategic Planning, and Talent (BEST); Provided an explanation of BEST and a review of the purpose and process.
- Update on Metal Detectors: CBO will provide an update and will review the survey data at the April 2025 Board meeting.

Public Comment:

- Chronic Absenteeism: Parent wanted to explain why her student has absences. Parent stated that teachers are out, substitute teachers are not paying attention to students, and students lack the motivation to come to school. Parent stated that there is a lack of motivation because her children informed her that they do nothing on Mondays. Parent Suggestion: The school should track both student and teacher absences.
