Individualized Education Program (IEP) Meeting Fees

The School acknowledges that the service fees set forth in this Agreement include Provider participation in up to one (1) Annual IEP meeting per student per contract year, not to exceed four (4) hours, and/or one (1) Triennial IEP meeting per student per contract year, not to exceed six (6) hours.

The School further agrees that any additional IEP meetings or related services beyond the Annual or Triennial IEP meetings described above — including, but not limited to, amendment IEPs, interim IEPs, manifestation determination meetings, resolution meetings, due process-related meetings, or meetings requested by the School or parent/guardian — shall be billed separately.

Such additional IEP-related services shall be billed at a rate of One Hundred Dollars (\$100.00) per hour, per Provider representative participating in the IEP meeting or related service, unless otherwise agreed to in writing by the Parties. Billing shall be based on actual time spent, including preparation, attendance, consultation, documentation, travel time (if applicable), and participation by clinical, educational, administrative, or supervisory personnel as reasonably necessary.

Such additional IEP-related services shall be billed at a rate of One Hundred Dollars (\$100.00) per hour, per Provider representative participating in the IEP meeting or related service, unless otherwise agreed to in writing by the Parties. Billing shall be based on actual time spent, including preparation, attendance, consultation, documentation, travel time (if applicable), and participation by clinical, educational, administrative, or supervisory personnel as reasonably necessary.
